SECTION IV: FIRST AID MEASURES

Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists get medical advice/attention.

SYMPTOMS OF EXPOSURE

Eye Contact: Eye irritation.

SECTION V: FIRE-FIGHTING MEASURES

Extinguishing Media: Water fog, foam, dry chemical powder, carbon dioxide (CO₂). Do not use water jet as an extinguisher, as this will spread the fire.

Specific Hazards from the Chemical: During fire, gases hazardous to health may be formed.

Hazardous Combustion Products: No unusual fire or explosion hazards noted.

Protective Equipment / Precautions for Firefighters: Self contained breathing apparatus and full protective clothing must be worn in case of fire. Move containers from fire area if you can do so without risk. Use standard firefighting procedures and consider the hazards of other materials involved.

SECTION VI: ACCIDENTAL RELEASE MEASURES

Personal Precautions: Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Wear appropriate protective equipment and clothing during cleanup. Do Not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained. For personal protection, see Section 8.

Environmental Precautions: Never return spills to original containers for re-use. For waste disposal, see Section 13. Avoid discharge into drains, water courses or onto the ground.

Methods for Cleaning Up: **Small Spills:** Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas. Following product recovery, flush area with water.

SECTION VII: HANDLING AND STORAGE

Safe Handling: Do not breathe mist or vapor. Do not get in eyes, on skin, or on clothing. Avoid prolonged exposure. Provide adequate ventilation. Wear appropriate protective equipment. Observe good industrial hygiene practices. Avoid release to the environment. Do not empty into drains.

Storage Conditions for Safe Storage, Including any Incompatibilities: Store in original tightly closed container. Store away from incompatible materials (see Section 10).

SECTION VIII: EXPOSURE CONTROLS / PERSONAL PROTECTION

Occupational Exposure Limits: None established.

Engineering Controls: Ensure good general ventilation. Eye wash stations and shower facilities should be readily accessible in areas where product is handled.

Engineering Controls: Good general ventilation (typically 10 air exchanges per hour) should be used. Ventilation rates should be matched to conditions. If applicable, use process enclosures, local exhaust ventilation, or other engineering controls to maintain airborne levels below recommended exposure limits. If exposure limits have not been established, maintain airborne levels to an acceptable level. Provide eye wash station.

PERSONAL PROTECTIVE EQUIPMENT (PPE)
