### SECTION IV: FIRST AID MEASURES

**Eye Contact:** Rinse with water for at least 15 minutes. Remove contact lenses if present and easy to do. Continue rinsing. Seek medical assistance immediately.

**Skin Contact:** Immediately remove all contaminated clothing. Rinse with water or shower for at least 15 minutes. If irritation persists, IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN.

**Inhalation:** Move victim to fresh air and keep at rest in a comfortable position for breathing. IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN.

**Ingestion:** Rinse mouth. DO NOT INDUCE VOMITING. IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN. Never give anything by mouth to an unconscious person.

**Note to Physician:** Probable mucosal damage may contraindicate the use of gastric lavage.

### SYMPTOMS OF EXPOSURE

**Eye Contact:** Pain, swelling, redness of the conjunctiva and tissue damage. Contact with eye may result in permanent damage.

**Skin Contact:** Pain, blistering, redness and possible chemical burn.

**Inhalation:** Irritation or damage to the mucus membranes of respiratory tract. Coughing and nasal discomfort.

**Ingestion:** Damage or chemical burns to mouth, throat and stomach. Pain, vomiting, nausea and diarrhea.

### SECTION V: FIRE-FIGHTING MEASURES

**Extinguishing Media:** Product does not support combustion. Use extinguishing agent suitable for type of surrounding fire.

**Specific Hazards from the Chemical:** Dried product is capable of burning.
