SECTION IV: FIRST AID MEASURES

Eye Contact: Rinse with water for at least 15 minutes. Remove contact lenses if present and easy to do. Continue rinsing. Seek medical assistance immediately.

Skin Contact: Immediately remove all contaminated clothing. Rinse with water or shower for at least 15 minutes. If irritation persists, IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN.

Inhalation: Move victim to fresh air and keep at rest in a comfortable position for breathing. IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN.

Ingestion: Rinse mouth. DO NOT INDUCE VOMITING. IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN. Never give anything by mouth to an unconscious person.

SYMPTOMS OF EXPOSURE

SECTION V: FIRE-FIGHTING MEASURES

Extinguishing Media: Product does not support combustion. Use extinguishing agent suitable for type of surrounding fire.

Specific Hazards from the Chemical: Dried product is capable of burning.
